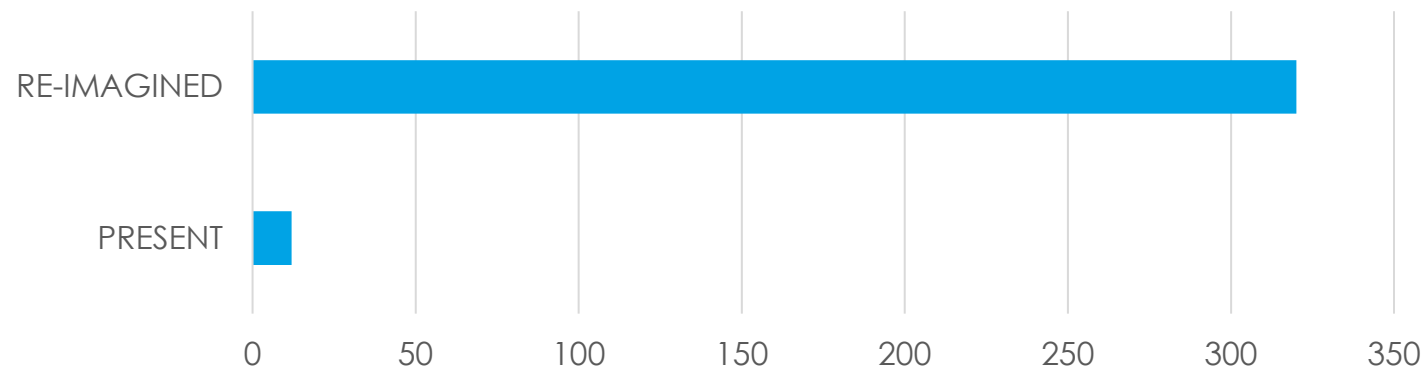

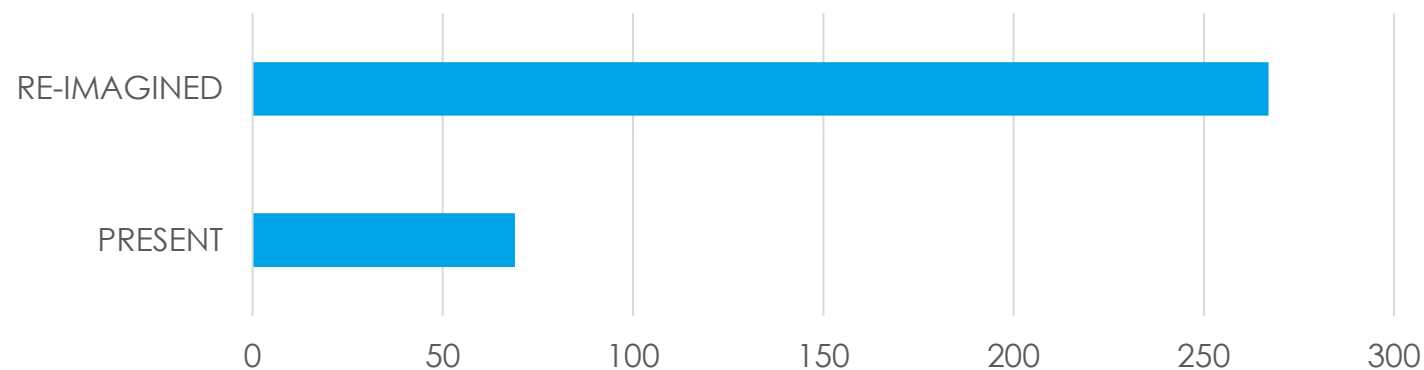

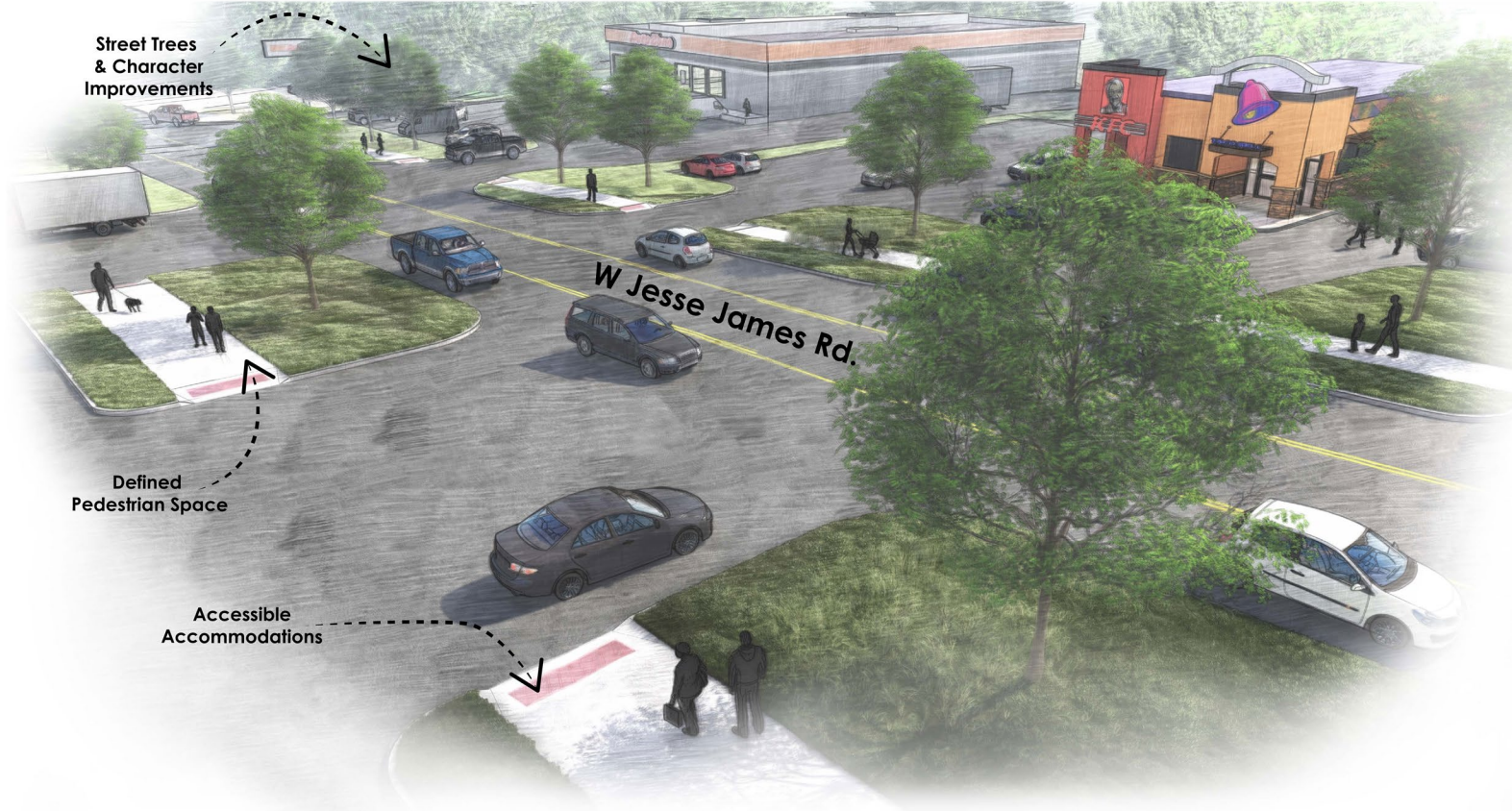




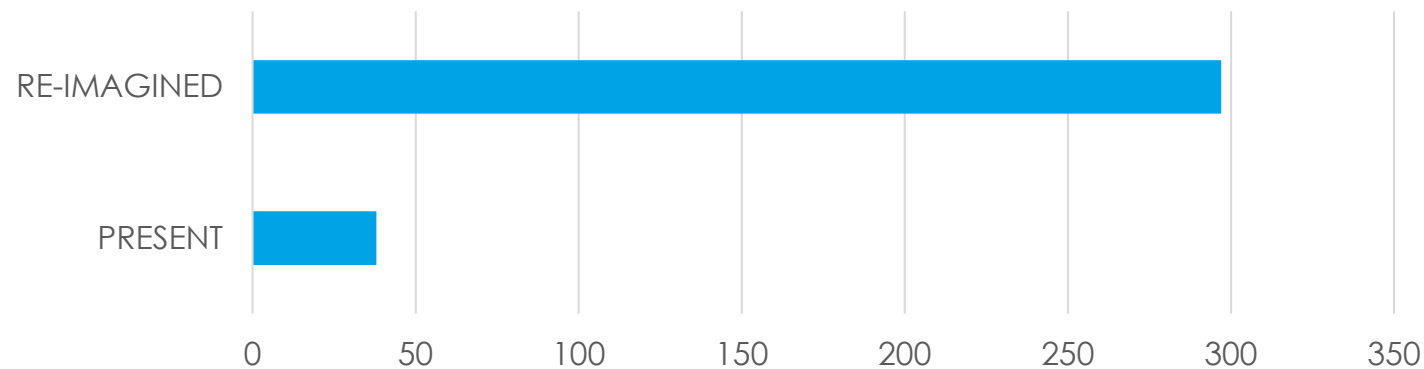

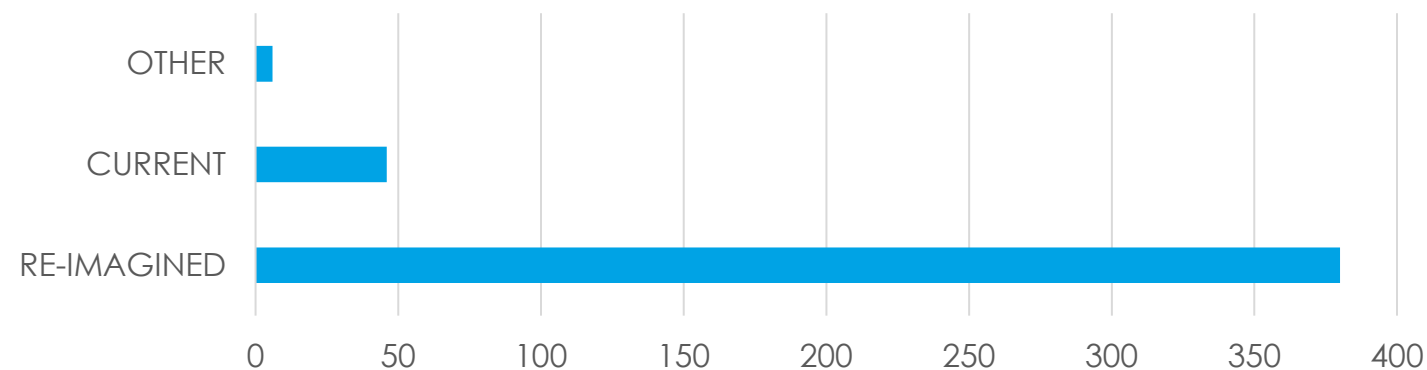

## PEDESTRIAN BRIDGE

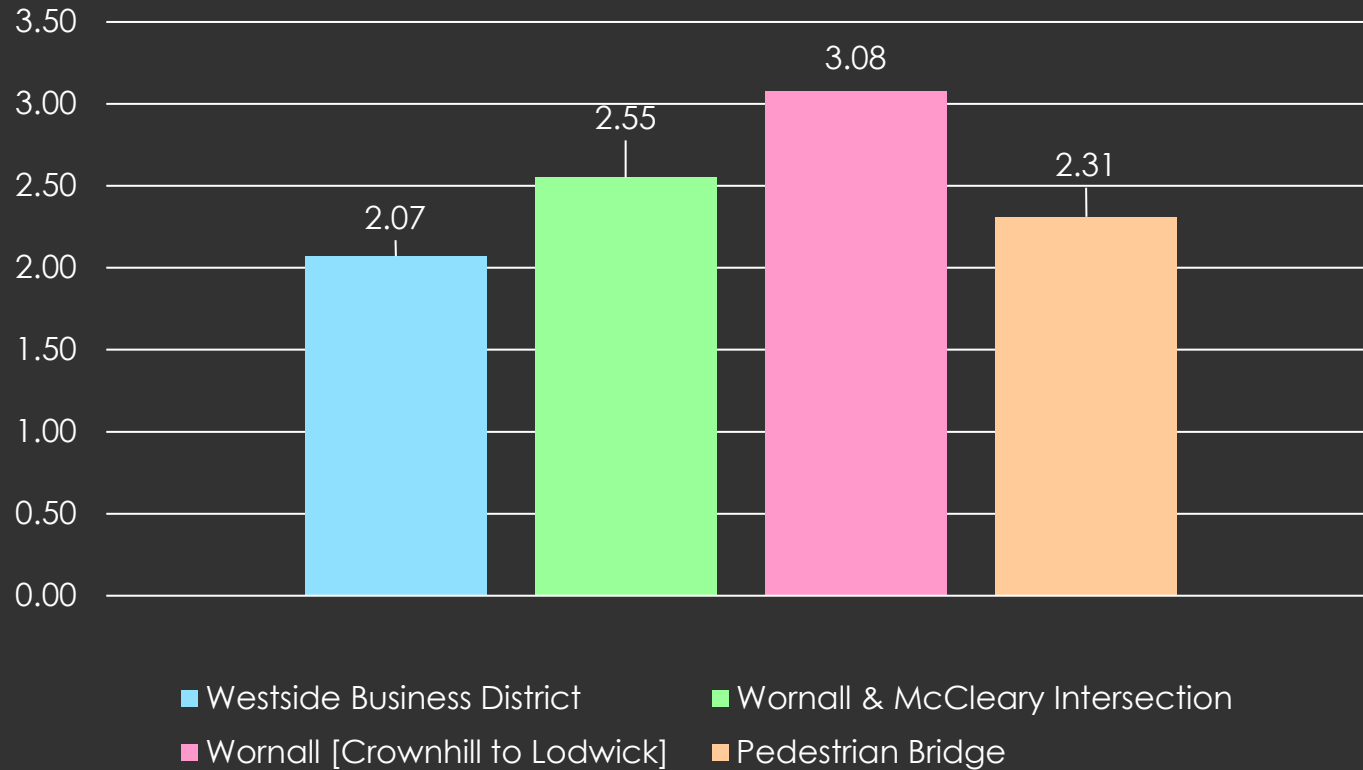

# COMMUNITY EDUCATION NEEDED

"We need to have sidewalks on Wornall road if there is going to be a school there. This should be the city's number one priority, if you decide to do anything else first then you will get a lot of backlash."

"Almost exclusively the pedestrians on Wornall Road are on the North side of the street...therefore I would recommend a standard sidewalk on the north side and also a standard sidewalk on the south side (even though it will tear up my beautiful front yard...at the present time there is NO pedestrian traffic on that south side."

"Yes, on the Wornall/Crown Hill/Lodwick area because of being near schools. The Pedestrian bridge over 69 could be a nice plus for the same reason. Kids can use the sidewalks in the neighborhoods to stay safe, even to get to the new school that will be in the area."

"Could support the pedestrian bridge, but not all the excess trees in this one and also no extra trees on the Jesse James one. They aren't necessary and create more upkeep."

"I do Not feel a roundabout is safe for pedestrian crossing or drivers. I feel traffic having to stop for pedestrians will be causing issues when roundabouts are for continuous flow of vehicles. During busy traffic volume stop signs are safer for all than yield signs that people barely slow for. I feel this proposed plan is actually more dangerous than current situation. At least the vehicles are supposed to stop and look which I believe is safer than a flow of movement barely yielding."
